5.1 <u>Approval of Draft Quality Assurance Procedures – Royal College of Physicians in</u> <u>Ireland (RCPI)</u>

The Committee noted the recommendation of the QQI executive (A30/5.1) based on the recommendation of the Quality and Capacity Evaluation Panel report (A30/5.2). Following discussion, the Committee accepted the recommendation of the QQI Executive to approve the application from the Royal College of Physicians with a Condition of QA Approval. RCPI is now approved to progress to Stage 2 of the access to initial programme validation process.

6. QUALITY ASSURANCE PROCEDURES

6.1 Approval of Draft Quality Assurance Procedures – Steer Training Academy

The Committee noted the recommendation of the QQI executive (A30/6.1) based on the recommendation of the Quality and Capacity Evaluation Panel report (A30/6.2). Following discussion, the Committee accepted the recommendation of the QQI Executive to approve the application from Steer Training Academy with 2 Conditions of QA Approval. Steer Training Academy is now approved to progress to Stage 2 of the access to initial programme validation process.

7. QUALITY ASSURANCE PROCEDURES

7.1 Approval of Draft Quality Assurance Procedures – Applicant Provider

The Committee noted the recommendation of the QQI executive (A30/7.1) based on the recommendation of the Quality and Capacity Evaluation Panel report (A30/7.2). Following discussion, the Committee accepted the recommendation of the QQI Executive to accept the findings of the panel report and therefore the Committee refused to approve, with recommendations, the application from the Applicant Provider.
