# 6. **REVALIDATION**

# 6.1 Application for Extension of Validation Period

### 6.1.1 The American College Dublin

The Committee NOTED the documentation circulated.

The American College Dublin successfully completed the reengagement process in Quarter 1 2021; the provider's Quality Assurance was approved at the PAEC meeting in February 2021. The American College indicated that it was necessary for it to direct all its resources towards the reengagement exercise, and so was unable to make any meaningful preparations for the review of its programmes, which under the current validation cycle would be expected to be largely completed this spring or early summer.

In addition, due to Covid-19 restrictions the pace at which the required materials could be adequately prepared was compromised as the main participants in the process were unable to work and meet collectively at the College. An extended timeframe for the revalidation would allow The American College to

accommodate its plan of work within the Covid-19 restrictions in the coming months.

# 6.1.2 St Nicholas Montessori College Ireland

The Committee NOTED the documentation circulated.

The three extensions to the programme to date were granted to provide learners that were on teach-out on the Level 7 Bachelor of Arts in Montessori Education with the progression opportunity to transfer to the oneyear add-on and obtain their level 8 award. The college now offers a Bachelor of Education (Honours) in Montessori Education programme with embedded Level 7 Bachelor of Education programme and no longer runs the Bachelor of Arts Level 7 programme.

The current extension request has an additional rationale. The programme is recognised by the Teaching Council for the purposes of registration as a Special Needs Teacher under Route 4 of its regulations. This route to registration is expiring no later than December 2023. As a result, SNMCI is experiencing substantial increased demand for the programme, not only from its own graduates but from graduates of similar programmes from other institutions who wish to avail of the route 4 registration option, while it is available.

# 6.1.3 City of Dublin Education and Training Board (CDETB)

Due to the current pandemic of COVID-19, CDETB has had to divert significant QA resources to manage the continuity arrangements for on and off the job delivery of the Advanced Certificate in Auctioneering and Property Services. An extension of validation would assist CDETB to put in place additional arrangements to implement the process of programme review and revalidation. CDETB has requested an extension for the Advanced Certificate in Auctioneering and Property Services until August 2022, which will allow for an active intake through the calendar year 2021. CDETB have indicated that they will have the review completed and revalidation application submitted to QQI in early 2022.

In addition, the College's ongoing consultation with the disability sector has shown that the context of people with disability and their services are changing in the present public health emergency. These changes will feed into any provision and support of this group post the emergency. The provision of this extension would allow the College to ensure the future curriculum includes these changes.

### **13. PUBLICATION OF APPROVED QA PROCEDURES**

#### 13.1 Publication of approved QA procedures

The Committee NOTED the documentation circulated.

Under Section 30(3) of the 2012 Act as amended, providers are obliged to publish their QA procedures as directed by QQI. QQI directs providers to publish their approved QA procedures on their websites.

In January and February 2021, QQI contacted all providers that had had their QA approved through either the reengagement or Initial Access to Validation processes to confirm that approved QA procedures had been published on the providers' websites as directed.

The Committee NOTED that all providers with QA procedures approved through the reengagement process have published those procedures to their websites as required under the 2012 Act.

#### 14.1 Reengagement Thematic Analysis – Publication of FAQ

In December 2020, QQI published its response to the thematic analysis and committed to producing an FAQ for the reengagement process based on discussions held with providers during peer learning events for applicants in November 2020. It committed to publishing this and a glossary of terms by the end of Q1 2021. This Glossary of Terms and FAQ was included in the documentation circulated to the Committee.

The Committee NOTED that QQI has now produced the Glossary of Terms and FAQs on the reengagement process within the timeframes committed to in its response to the thematic analysis of reengagement. It is intended that, following incorporation of any additional feedback from this Committee, the Glossary and FAQs will be published to the QQI website in April 2021.

### 15. UPDATE ON MEASURES TO MITIGATE IMPACT OF COVID-19 PANDEMIC ON PROGRAMMES LEADING TO QQI AWARDS

#### 15.1 Update on Measures to Mitigate Impact of COVID-19 Pandemic on Programmes Leading to QQI Awards

The Committee NOTED the verbal update by the executive on measures to mitigate the impact of COVID-19 Pandemic on programmes leading to QQI awards.

The Committee NOTED that the Policies and Standards Committee at its meeting on 15 March 2021 agreed to extend the QA Approval/Validation measures to mitigate the impact of COVID-19 pandemic on programmes leading to QQI awards to the end of August 2022. The update regarding the extension has been published on the QQI website.

### **16. PROCESS FOR THE EVALUATION OF MICROCREDENTIAL PROGRAMMES**

# 16.1 Process for the Evaluation of Microcredential Programmes

The Committee NOTED the documentation circulated.

In summer 2020, when public funding was made available for HET 'microcredentials', QQI undertook a pilot process for validation of those programmes to which this term has been applied. With the cooperation of private HET providers, a process was developed whereby the providers could submit, for a streamlined validation process, standalone programmes of between 5 and 30 ECTS which led to QQI special purpose awards. Since the programmes had already been through a larger validation process, QQI applied a streamlined model for evaluation while ensuring that the fundamentals of the validation process were maintained.

Following consultation with the provider sector, QQI agreed to extend the model to microcredentials comprising multiple modules from a single validated programme. It was also agreed that providers with approval for devolved responsibility (DR) could seek to include microcredentials within the scope of their DR. The process templates were modified accordingly.

There is continued demand from the provider sector that the model for microcredentials be extended further to include:

- new programmes i.e. no connection to a previously validated programme
- modification of modules which had been taken from a previously validated programme(s)

As the boundaries have been extending, there is a need to clearly **define** a microcredential within the QQI remit to achieve stability and common understanding. Also, the various permutations of microcredential being proposed need to be accommodated within a clear process for validation, while also recognising that there will be variations which have an impact on how the proposal is evaluated.

Following discussion, the Committee DEFERRED a decision on a definition for microcredentials within the QQI Awards context pending further consideration by the executive and in consultation with other national and international stakeholders.

The PAEC APPROVED for an interim period of one year to end of April 2022 the proposed procedure for the evaluation of Microcredentials as outlined below:

# **Proposed Procedure for Evaluation of Microcredentials**

- 1. All applications will be documented in a single descriptor template (template was included in the documentation).
- 2. The descriptor will be accompanied by a document setting out the rationale and business case for the programme.
- 3. All applications will be made via QHub to ensure that all the necessary data and documentation is supplied.
- 4. All applications will be screened by QQI.
- 5. QQI will retain the right to decide whether a programme is evaluated by desk audit or by panel meeting. This will depend on the novelty of the programme.
- 6. The evaluation process, including selection of and communication with the panel, may be managed by QQI or by a provider with devolved responsibility.
- 7. A panel conducting the evaluation by desk audit will be able to seek clarification about the application. A document template is provided for this purpose. Alternatively, the panel chair may request QQI / provider with DR to arrange a virtual meeting.
- 8. The panel will report its findings using a defined report template.
- 9. The decision of validation will be made by PAEC in the normal manner and the panel report will be published.
