As a result of the pandemic the delivery of the craft apprenticeship programmes has been severely interrupted since March 2020. Due to the current model of delivery of the craft apprenticeship programmes 3,000 plus apprentices had their off-the-job craft training interrupted. Therefore, work on the continuity of teaching, learning and assessment for the 25 craft programmes has been prioritised.

SOLAS is now implementing a plan to remedy the backlog of apprentices. SOLAS was planning to complete programme review, and stakeholder engagement during this time. SOLAS requested an extension until December 2022.

The Committee APPROVED the request to extend the last intake date of the programmes to December 2022.

The Committee REQUESTED that SOLAS provide a progress report for the PAEC meeting in June 2022.

13. USE OF NON-CAS SPECIAL PURPOSE AWARD AS CREDIT TOWARDS A CAS MAJOR AWARD IN FET

13.1 Use of Non-CAS Special Purpose Award (SPA) as Credit Towards a CAS Major Award in FET

The Committee NOTED the documentation circulated. Since the implementation of the 2017 Validation policy and criteria, it has been possible for FET providers to submit programmes for validation to lead to awards which are not part of the Common Awards System (CAS).

There have been requests to QQI, to enable learners holding these new awards to be able to use the credit towards a related CAS major award. Below is an outline of how an award holder on a programme could use the credit towards a CAS major award:

- A new CAS component with the same title as the SPA would be created and included in the pool structure of the CAS major award as an elective component.
- The new CAS component would have the same attributes as the other components in the pool i.e. certifiable and usable for CAO. It would not however have an award specification.
- A learner presenting the SPA certificate would be entitled to be entered into the QQI certification system for the CAS component provided s/he was using the credit towards achievement of the major award.

The Committee NOTED that the executive will present a paper outlining the approach to the Policies and Standards Committee for approval.
