6.1 Application for Extension of Validation Period

6.1.1 Carlow College, St Patricks

The Committee NOTED the documentation circulated. Carlow College, St Patricks requested a one-year extension of validation for the following programmes:

The rationale for this request was as follows:

Carlow College has been engaged in discussions with the Department of Further and Higher Education, Research, Innovation and Science and the Higher Education Authority, since 2017, regarding the strategic repositioning of the College. Carlow College has stated that it wants full integration into the Higher Education System as part of South East Technological University (SETU).

Carlow College has indicated that, to best position the College for its integration into the Higher Education System in the South East, it seeks an extension of one year for it programmes that are in their final year of validation.

The Committee APPROVED the request to extend the last intake date of the programmes above to September 2023.

The rationale for this request was as follows:

SOLAS indicated that its resources and efforts are currently being deployed into ensuring that the initial five craft apprenticeships will be revalidated in early 2023.

SOLAS is requesting an extension for the programmes until December 2023 to allow for an active intake in August 2023. SOLAS expects to complete the programme review in the latter months of 2023.

The Committee APPROVED the request to extend the last intake date of the programmes above to December 2023.

6.2 Applications for Revalidation

6.2.1 Hibernia College – Pilot Process

6.2.1.1 Professional Master of Education in Primary Education, Level 9, Major Award, 120 Credits

The Committee NOTED the documentation circulated. In 2020, after consultation with Hibernia College and within QQI, QQI approached the Teaching Council with a proposal for a pilot project to synchronise the separate academic validation and professional accreditation processes e.g. through alignment of documentation, timelines, panel members etc.

The Teaching Council did not wish to collaborate in a pilot (with alignment of documentation and panel members). However, to ease the demands of two evaluations on the provider, QQI progressed with a pilot to synchronise the timelines of the respective validation and professional accreditation processes.

A process was agreed between QQI and Hibernia College.

The PAEC noted the pilot for synchronising the timelines of academic and professional accreditation processes.

The Committee NOTED the executive now considers the conditions **one** and **two** of QA approval to be met and that no further follow-up is required.

9. APPROVAL OF QUALITY ASSURANCE PROCEDURES FOR LEGACY PROVIDERS (RE-ENGAGEMENT)

9.1 Approval of Quality Assurance Procedures for Legacy Providers (Re-Engagement)

9.1.1 A NAMED PROVIDER

The Committee NOTED the documentation circulated.

The Committee REFUSED TO APPROVE WITH RECOMMENDATIONS (pending mandatory changes being made) the named provider's application for QA Approval. The named provider may submit revised procedures for approval within a six-month period of notification of this decision.

9.1.2 A NAMED PROVIDER

The Committee NOTED the documentation circulated.

The Committee REFUSED TO APPROVE WITH RECOMMENDATIONS (pending mandatory changes being made) the named provider's application for QA Approval. The named provider may submit revised procedures for approval within a six-month period of notification of this decision.

9.1.3 A NAMED PROVIDER

The Committee NOTED the documentation circulated.

The Committee REFUSED TO APPROVE WITH RECOMMENDATIONS (pending mandatory changes being made the named provider's application for QA Approval. The named provider may submit revised procedures for approval within a six-month period of notification of this decision.

9.1.4 A NAMED PROVIDER

The Committee NOTED the documentation circulated.

The Committee REFUSED TO APPROVE WITH RECOMMENDATIONS (pending mandatory changes being made) the named provider's application for QA Approval. The named provider may submit revised procedures for approval within a six-month period of notification of this decision.

9.1.5 Hi-Tech Training

The Committee NOTED the documentation circulated.

The Committee APPROVED WITH CONDITIONS the core quality assurance procedures of Hi-Tech Training.

The Committee NOTED that the executive now considers all the conditions of QA approval to be met.

10. ROUTINE STANDARDS ACTIVITIES UPDATE

11. CHANGE OF STATUS OF LEGACY HET AND FET PROVIDERS

11.1 Change of Status of Legacy HET and FET Providers

The Committee NOTED the documentation circulated. Sixty-four providers were to have their QA Agreements rescinded and the validation of their programmes withdrawn due to:

- A. voluntary decision by the providers not to reengage
- B. decision to become a second provider to an ETB as an alternative to reengagement
- C. Voluntary decision by provider not to reengage but to instead become a centre of a larger provider other than an ETB

All providers listed in the documentation have been met virtually by QQI and have had the opportunity to agree a wind-down process to ensure that any programme in process and/or certification in process has been completed.

The Committee APPROVED the withdrawal of approval of the providers' quality assurance and withdrawal of validation of the associated programmes. The executive will send a registered letter of notification to each provider.

The Committee NOTED that this concluded the process of withdrawal of approval of legacy providers who had chosen not to reengage. A total of 315 providers will have had QA approval withdrawn since February 2018, leaving a total of 232 relevant providers.

12. WITHDRAWAL OF PROVIDER QA APPROVAL

12.1 WITHDRAWAL OF PROVIDER QA APPROVAL

The Committee NOTED the documentation circulated. A Named Provider has been forced to cease operations due to a fall-off in business post pandemic. The named provider had completed reengagement and had almost completed the approval process for blended learning when its Board took the decision to cease operations. The closure was orderly and done with full transparency.

QQI made arrangements with the named provider that all learners who had certification pending were enabled to complete and attain their awards.

The Committee APPROVED the withdrawal of approval of the named provider's quality assurance which will be noted by the Board. The named provider's validated programmes will then be withdrawn.

13. INTENTION TO WITHDRAW VALIDATION OF PROGRAMMES

13.1 Intention to Withdraw Validation of Programmes

The Committee NOTED the documentation circulated. QQI contacted all Higher Education and Training (HET) private providers and a number of Further Education and Training (FET) private providers who had returned information via the Protection for Enrolled Learners (PEL) audit, to confirm those programmes which should have their validation withdrawn. Twenty-seven HET and 41 FET providers have confirmed which programmes should have validation withdrawn as the programmes have either gone past the validation period of enrolment or have ceased to be offered to learners.

The Committee NOTED the intention to withdraw validation of programmes.

13.2 A Named Provider

The Committee NOTED the documentation circulated.

At the April 2022 PAEC meeting, the PAEC approved, with conditions, a programme of a named provider.

The provider subsequently informed the QQI Executive that it intended not to proceed with the programme, and a letter formally requesting the withdrawal of the validation submission was received in October 2022.

QQI informed the provider that withdrawal of a validation submission is not an option post the evaluation stage of the process, and that failure to meet outstanding conditions mandates a withdrawal of validation by

the PAEC. The named provider was informed that the executive would bring the programme back to the PAEC with a recommendation that it withdraw validation under section 47 of the 2012 Act.

As the outstanding conditions of validation have not been met, the Executive requested the PAEC to consider the withdrawal of validation for this programme.

The Committee APPROVED the withdrawal of validation of the programme.

14. REPORT FROM THE PROGRAMMES AND AWARDS OVERSIGHT COMMITTEE (PAOC)

14.1 Report From the Programmes and Awards Oversight Committee (PAOC) of 1 November 2022

The Committee NOTED the documentation circulated. At its meeting on 1 November 2022, the PAOC reviewed the decisions of the PAEC meeting of 22 September 2022 to refuse validation of two programmes. The PAOC CONFIRMED the decision of the PAEC to refuse validation of the two programmes.

15. SOLAS - UPDATE REPORT ON CRAFT APPRENTICESHIP REVALIDATION

15.1 SOLAS - Update Report on Craft Apprenticeship Revalidation

The Committee NOTED the documentation circulated. On 4 April 2022, SOLAS updated QQI on the revalidation of the 'five craft apprenticeship programmes' project currently underway. It was agreed that SOLAS would submit regular status reports to QQI.

On 23 May, SOLAS submitted the status reports on the five craft apprenticeships which was presented to the PAEC members in June 2022. SOLAS was expected to have revalidation applications submitted to QQI in the third quarter of 2022.

On 8 September, SOLAS submitted the status report on the five apprenticeships which was presented to PAEC on 22 September 2022.

On 3 November, a meeting was held to discuss revalidation, extensions of 12 craft apprenticeship programmes, QA concerns and legacy craft award codes.

On 16 November, SOLAS submitted the status report on the five apprenticeships highlighting a further delay in meeting the deadline of December 2022. The report requests an extension for 12 craft apprenticeships.

16. ANNUAL SELF-ASSESSMENT OF PERFORMANCE OF COMMITTEE - 2021

16.1 Annual Self-Assessment of Performance of Committee – 2021.

The Committee NOTED the documentation circulated.

QQI is required under the Code of Practice for the Governance of State Bodies (2016) to carry out an annual self-assessment of the Board and its Committees. All members of the PAEC were invited to partake in a self- evaluation of the performance of the PAEC through a short survey.

The areas addressed included Roles and Responsibilities; Composition and Conduct of Committee Meetings; Adequacy of Committee Information; and Communications. An initial analysis of the responses

indicated that the Committee is very satisfied in the majority of areas covered by the evaluation. It was highlighted that the attendance by Programmes and Awards Oversight Committee (PAOC) observers is very useful and that the assignment of individual agenda items to specified committee members to lead on is effective.

The Committee's additional comments at the meeting included the following:

- Membership of the Committee is important and beneficial for the development of the executive.
- It would be useful if we routinely captured follow-up information on the programmes following validation.
