13.1 Change to Award Classifications – Professional Master of Education Programmes

The request to amend the classification was made to improve consistency with the classifications applied by other national awarding bodies for this award type, particularly in respect of the width of the Pass grade band. In order not to disadvantage graduates of these programmes, the changes will be applied retrospectively to all learners who have graduated in the period 2016 to date.

The Committee ACCEPTED the recommendation of the executive to change the classification for named award Professional Master of Education so that it more closely aligns to the practice of other national awarding bodies.
