Introduction

The Qualifications and Quality Assurance (Education and Training) Act 2012 requires QQI to prepare a strategy statement which sets out the objectives of QQI and strategies for achieving them, and the uses to which QQI proposes to apply its resources. This statement sets out the mission, vision, values, goals and priorities which will guide QQI and focus its work in the three year period 2014-2016. It will be supported by and implemented through more detailed objectives and actions in QQI's business plans for the period.

THE PURPOSE OF THIS FIRST STRATEGY STATEMENT IS TO:

- » Capture the purpose of QQI and its functions under the 2012 Act
- » Adequately describe the difference we want to make and see happen
- » Capture the core values that underpin our work and are critical to our success
- » Identify the major goals we must achieve from 2014-2016 to carry out our mission and reach our vision
- » Address the challenges and opportunities facing QQI from 2014-2016.

THE FOLLOWING CONSIDERATIONS INFORMED THE STATEMENT:

- » The diverse range of functions that QQI is legislated to undertake including facilitating key stakeholders in meeting their responsibilities under the 2012 Act
- » What we believe can realistically be achieved in the three year period
- » The early stage of development of QQI – in 2013, QQI is a) developing its governance structures including mechanisms to engage effectively with stakeholders; b) developing a comprehensive suite of policies; c) integrating business processes; d) integrating human resource policies and e) continuing to offer services to its providers and the public
- » The factors which will enable QQI to achieve its goals in the period 2014-2016
- » The external and internal challenges and opportunities facing QQI.

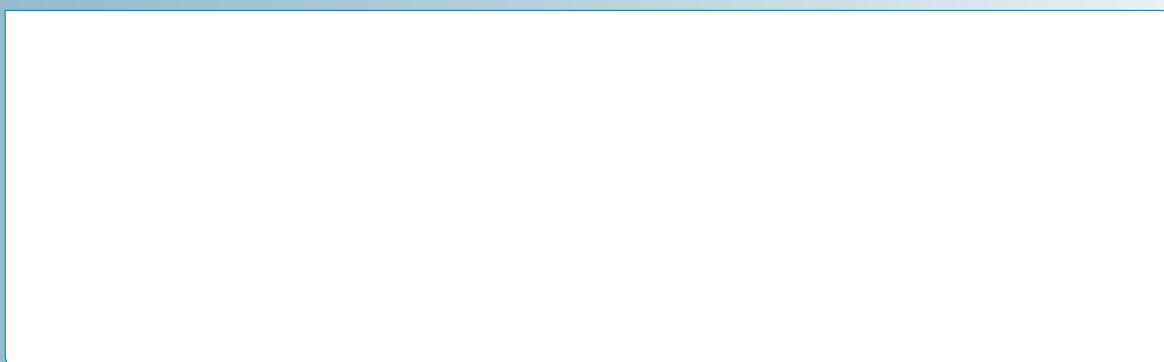

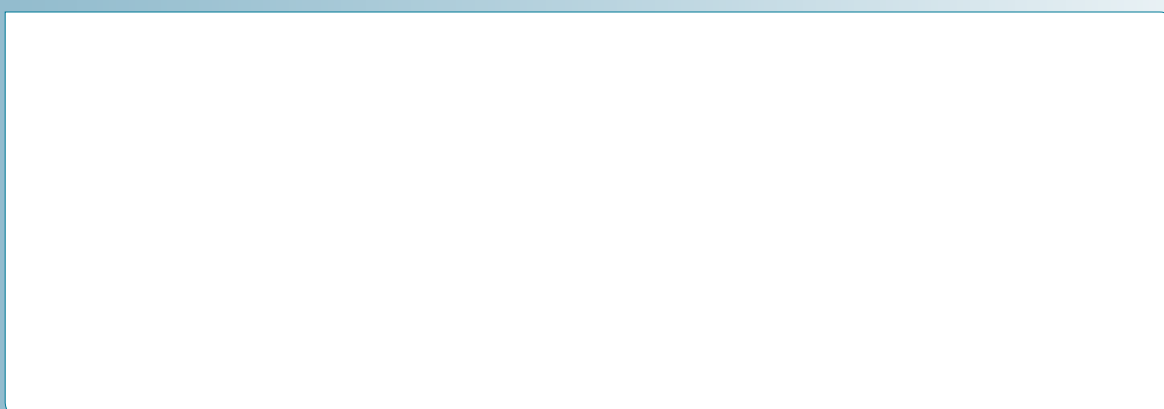

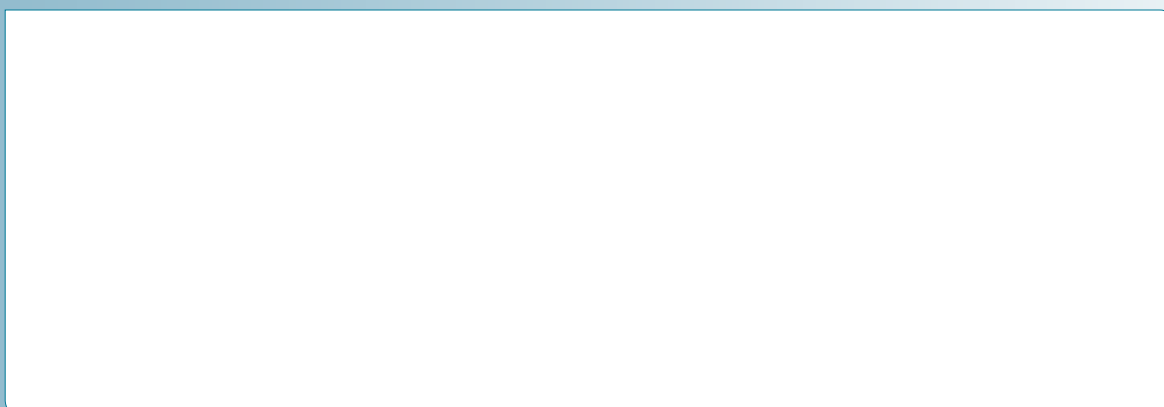
1. *Establish a comprehensive, coherent set of QQI policies and processes with the National Framework of Qualifications as the central organising feature*

PRIORITIES

- » Integrate the functions of QQI through adopting and implementing a comprehensive policy development programme
- » Promote, update and implement the National Framework of Qualifications
- » Determine new standards for QQI awards to meet learner and labour market demands
- » Regulate access by national and international awarding bodies to the National Framework of Qualifications
- » Charge appropriate ministerially-approved fees for QQI services
- » Provide external quality assurance and access to programme accreditation for new further and higher education and training providers
- » Establish and operate the International Education Mark
- » Liaise with professional recognition bodies in relation to the National Framework of Qualifications

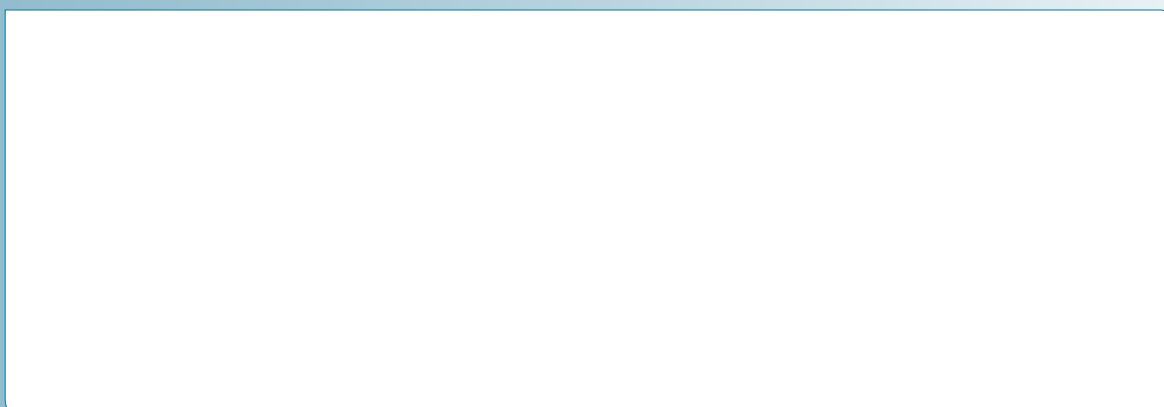

PRIORITIES

- » Engage learners in QQI's quality assurance processes and encourage others to do likewise
- » Implement statutory provisions for the protection of enrolled learners
- » Develop quality standards and guidelines to address the internationalisation of education, collaborative provision and changing forms of programme delivery
- » Certify learners who complete programmes validated by QQI
- » Provide new statutory guidelines for access, transfer and progression for learners to facilitate providers in meeting their statutory responsibilities
- » Provide qualification recognition advice to learners
- » Promote the international recognition of Irish qualifications
- » Respond to emergent concerns about standards and quality which relate to providers that are quality assured by QQI

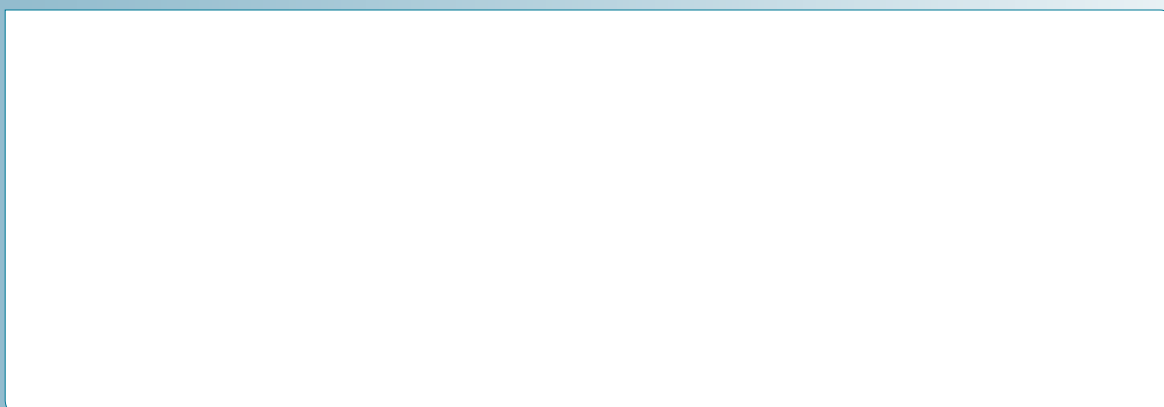
3. Base our relations with providers on their capacity to meet robust standards to maintain and improve quality

PRIORITIES

- » Relate with providers based on autonomy, capacity and respective responsibilities
- » Test models for how QQI regulates, including risk and proportionality based approaches
- » Provide access to programme accreditation to providers who meet robust standards and can continue to fulfil the associated quality assurance requirements
- » Re-engage with providers that had relationships with the legacy bodies (Further Education and Training Awards Council, Higher Education and Training Awards Council, National Qualifications Authority of Ireland and the Irish Universities Quality Board) on the basis of the 2012 Act
- » Manage and evolve comprehensive, effective quality assurance relations with the Education and Training Boards and SOLAS
- » Manage QQI's engagement with higher education providers in the context of the implementation of the National Strategy for Higher Education
- » Seek opportunities to facilitate collaboration among providers on matters of common interest
- » Monitor and review the quality assurance arrangements of relevant providers

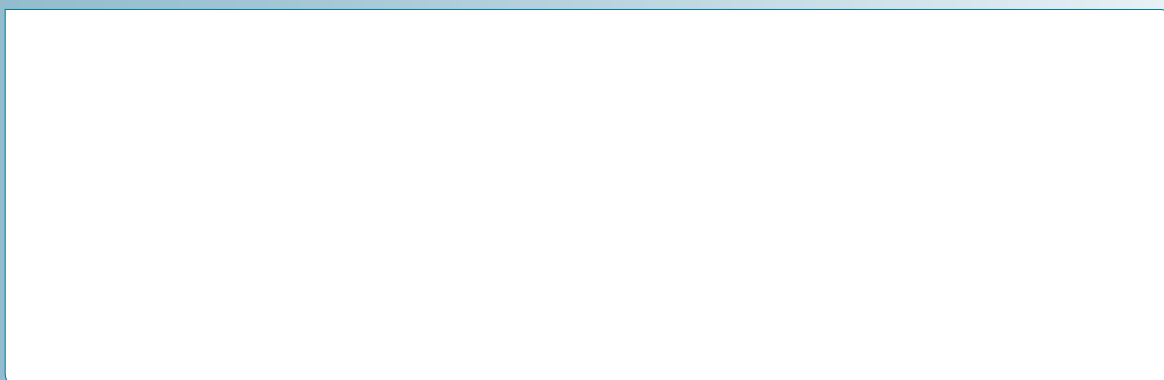


4. *Promote coherence of the education and training system in collaboration with stakeholders, based on clearly defined roles and responsibilities for QQI*

PRIORITIES

- » Respond to funding agencies and government departments by clarifying mutual roles and responsibilities in order to achieve joined-up approaches to quality and qualifications and to related policy initiatives
- » Engage with regulatory bodies to establish QQI's role in setting standards for qualifications and quality and to maintain confidence in education and training qualifications
- » Develop relations with designated awarding bodies with regard to their quality assurance responsibilities for linked providers
- » Encourage and facilitate innovation and responsiveness in qualifications and programmes to meet societal and cultural needs
- » Work with employers and trade unions to promote the relevance of the education and training system and its qualifications to the labour market
- » Develop and maintain effective relationships with professional recognition bodies and awarding bodies
- » Facilitate the sharing of good practice among stakeholders on quality and qualifications
- » Maintain and extend relationships with international peer agencies
- » Consistently implement the agreed *QQI Framework for Consultation* with stakeholders on policy and organisational developments
- » Identify and establish a range of effective communications tools and mechanisms for different stakeholder groups

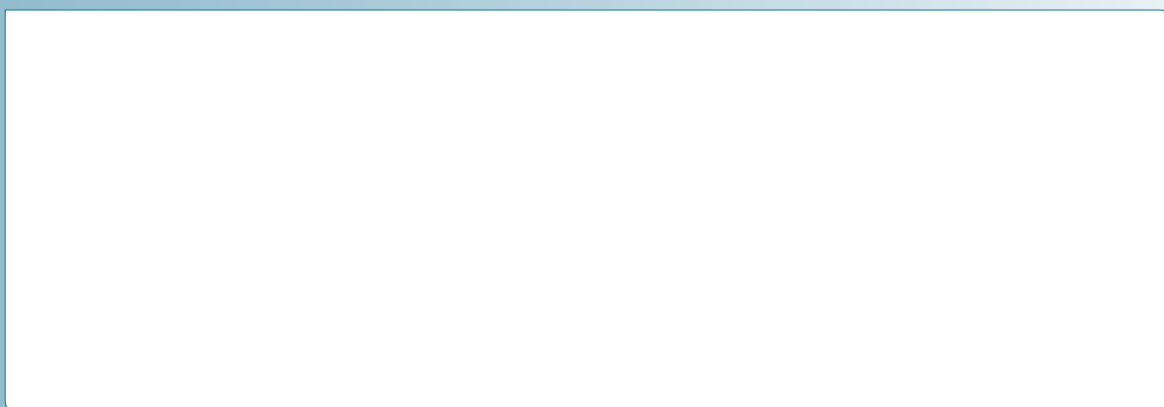


5. Provide authoritative information on programmes and qualifications to the public

- » Continue to provide information on programmes and qualifications directly to learners
- » Develop and publish a comprehensive national database of quality assured programmes and qualifications
- » Clearly articulate the QQI standards which are associated with programmes, qualifications and the International Education Mark
- » Require providers to make available relevant, accessible, accurate and timely information on quality, programmes and qualifications to learners and the public
- » Publish the outcomes of QQI's quality assurance and regulatory activities
- » Analyse the outputs of QQI's quality assurance and regulatory activities in order to inform national policies and initiatives in education and training
