### **5.2 Higher Education and Training Programmes – Programme Validation**

#### **5.2.0 Validation of Microcredentials – An Overview**

The executive provided an overview on microcredentials to the Committee.

There were seven novel HET applications for validation. They were novel in a number of ways:

- The application documentation is reduced, reflecting the fact that the programmes are ‘modular’ i.e. in each case, based on a module of an already validated programme.
- The evaluation method was desk audit rather than by panel meeting.
- The report template has been modified.

These applications were the product of a pilot entered into by QQI in conjunction with eight private HEIs. The purpose of the pilot was to establish and refine a method of validating microcredentials i.e. small (5 - 25 ECTS) programmes leading to special purpose awards, where the content of the programme has already been through a validation process.

This initiative is a response to a government funding initiative for microcredentials, launched as part of the July 2020 stimulus. Public and private HEIs are to be funded to offer short programmes to learners seeking upskilling or retraining. One criterion of the funding was that any such programme should be based on a module(s) from a programme validated by QQI or another Irish awarding body. There was no requirement that the modular programme itself should lead to an award.

The Committee NOTED that panel members and providers will be consulted on their experience of the pilot with a view to refinement.

#### **5.2.1 Bridge Mills Galway Language Centre**

## **6. REVALIDATION**

### **6.1 Application for Extension of Validation Period**

### 6.1.1 Kerry Education and Training Board

The Committee NOTED the documentation circulated.

Due to the current pandemic, Kerry ETB indicated that they had to divert significant QA resources to manage the continuity arrangements for on and off the job delivery of the Advanced Certificate in Culinary Arts. An extension of validation would assist Kerry ETB to put in place additional arrangements to implement the process of programme review and revalidation and to ensure compatibility with remote communications.

Kerry ETB requested an extension of the validation period for the Advanced Certificate in Culinary Arts until December 2021 to allow for an active intake through the calendar year 2021. Kerry ETB will have the review completed and revalidation application submitted to QQI in the latter months of 2021.

The Committee APPROVED the request to extend the last intake date for the following programme for one year:

6.1.1.1 PG23401, Advanced Certificate in Culinary Arts, Level 6, Major Award, 240 FET Credits

### 6.1.2 SOLAS

The Committee NOTED the documentation circulated.

As a result of the pandemic, the delivery of the craft apprenticeship programmes has been severely interrupted since March 2020. Due to the current model of delivery of the craft apprenticeship programmes, 3,000+ apprentices had their off-the-job craft training interrupted. Therefore, work on the continuity of teaching, learning and assessment for the 25 craft programmes has been prioritised.

SOLAS has had to divert significant QA resources to manage the continuity arrangements for 25 craft apprenticeship programmes. SOLAS was planning to complete programme review, and stakeholder engagement during this time. With current resources, SOLAS will not be able to complete the necessary activities to review and update the five named programmes.

SOLAS requested an extension until December 2021. SOLAS expects to have the review completed and revalidation applications submitted to QQI in the latter months of 2021.

The Committee APPROVED the request to extend the last intake date for the following programmes for one year:

### 6.1.3 Hibernia College

The Committee NOTED the documentation circulated.

The Professional Master of Education in Primary Education and the Professional Master of Education in Post-Primary Education programmes are approved by the Teaching Council for the purposes of

teaching in primary and post-primary schools respectively. The timelines for approval of these programmes with the Teaching Council were synchronised with QQI validation and programme review periods i.e. they are approved for five years. Both programmes were due for review with QQI and the Teaching Council during 2019.

The Teaching Council is not in a position to accept applications for re-approval as yet. The Teaching Council published its revised criteria and guidelines for programme providers during the week commencing 9 November 2020 and have indicated that they will commence the next cycle of review and accreditation in September 2021 with a view to all revised programmes commencing delivery from September 2022. A one-year extension to the QQI validation period for these programmes will enable Hibernia College to synchronise its QQI review and revalidation processes in line with the Teaching Council's reaccreditation processes.

The Committee APPROVED the request to extend the last intake date for the following programmes for one year:

- 6.1.3.1 PG21507, Professional Master of Education in Primary Education, Level 9, Major Award, 120 Credits
- PG21195, Professional Master of Education in Post-Primary Education, Level 9, Major Award, 120 Credits

The Committee NOTED the documentation circulated.

Hibernia College requested that QQI facilitate the alignment of the professional recognition of the programme below with the Nursing and Midwifery Board of Ireland (NMBI) and programme validation with QQI, by extending the first and last intake dates for the programme to January 2021 and January 2025, respectively. Hibernia intends to have its first intake to the programme in January 2022.

The Committee APPROVED the request to amend the enrolment interval for the programme as outlined above.

## **6.2 Application for Modification of Validated Programme**

### **6.2.1 Dorset College**

The Committee NOTED the documentation circulated. Dorset College requested permission to increase enrolment in the programme below by 150 learners to an annual total of 350 learners over two intakes:

The Committee APPROVED the additional enrolment numbers for one year i.e. January and September 2021 intakes, but a report will be required from Dorset College following surveys of September 2020 and January 2021 intake cohorts as to their experience of the programme. The report is also to examine the operation and effectiveness of Recognition of Prior Learning (RPL) process for entry, based on comparative analysis of outcomes.

## **6.3 Applications for Revalidation**

The Committee NOTED the documentation circulated. The Committee APPROVED the revalidation of the following programmes for five years subject to any special conditions of validation, and all the conditions from the current validation policy listed in the proposed Certificate of Validation:

## **7. FOLLOW-UP ON PAEC RECOMMENDATIONS AND CONDITIONS IN PANEL REPORTS**

#### **7.1.1 Farm Ed Ltd**

QQI is required to follow up on any special conditions of validation identified by an evaluation panel. The special conditions of validation that require follow-up are any conditions that have yet to be met at the time of the PAEC meeting at which the relevant application for validation is being considered at, or those conditions that are ongoing in nature and will require explicit monitoring for the period for which the programme has been validated.

The Committee noted the documentation circulated.

In September 2019, QQI validated the following two programmes for one year, allowing Farm Ed Ltd four intakes to both programmes with a maximum of 30 learners per intake (120 learners in total) on condition that provider review the programmes after one year and report back to the PAEC to review.

- PG23812, Agriculture, Level 5, Major Award, 120 FET Credits
- PG23814, Farming, Level 6, Special Purpose Award, 50 FET Credits

Due to the pandemic, it was agreed that the Farm Ed Ltd review of programme delivery would be postponed until Q4 2020.

Following discussion, the Committee agreed to extend the validation of both programmes by one year until the end of December 2021. Farm Ed Ltd is approved for a maximum of four intakes to both programmes with a maximum of 30 learners per intake. The executive is to request the provider to submit detailed plans for programme delivery during 2021, including programme schedules and timetables.
