## **6. REVALIDATION**

### **6.1 Application for Extension of Validation Period**

#### **6.1.1 Galway Business School**

The Committee NOTED the documentation circulated.

In November 2021, Galway Business School requested a one-year extension of validation for the programme stated below to allow a September 2022 intake, which would facilitate continuity of provision for the programme and allow them to prepare for revalidation.

6.1.1.1 PG22708, Bachelor of Business (Honours) with International Business, Level 8, Major Award, 60 Credits

Galway Business School indicated that because of the pandemic, there were less resources to conduct programme revalidation in the academic year 2021/2022 than planned.

The Committee APPROVED the request to extend the last intake date of the programme to August 2023.

#### **6.1.2 City of Dublin ETB**

The Committee NOTED the documentation circulated.

In October 2021, City of Dublin Education and Training Board (CDETb) requested a one-year extension of validation for the programme below.

6.1.2.1 PG23904, Advanced Certificate in Auctioneering and Property Services, Level 6, Major Award, 240 FET Credits (Apprenticeship).

Due to the current pandemic, City of Dublin ETB indicated that they had to divert significant QA resources to manage the continuity arrangements for on and off the job delivery of the Advanced Certificate in Auctioneering and Property Services. An extension of validation would assist CDETb putting in place additional arrangements to implement the process of programme review and revalidation.

The Committee APPROVED the request to extend the last intake date of the programme to August 2023.

#### **6.1.3 Limerick and Clare ETB**

The Committee NOTED the documentation circulated.

In November 2021, Limerick and Clare ETB (LCETB) requested a one-year extension of validation for the programme below.

6.1.3.1 PG24113, Advanced Certificate in Hairdressing, Level 6, Major Award, 225 FET Credits (Apprenticeship)

Due to the current pandemic, LCETB indicated that they had to divert significant QA resources to manage the continuity arrangements for online delivery of the Advanced Certificate in Hairdressing. LCETB requested an extension for the programme until December 2022 to allow for an active intake through the calendar year 2022. LCETB expects to complete the programme review in the latter months of 2022.

The Committee APPROVED the request to extend the last intake date of the programme to December 2022.

6.1.4 **SOLAS**

The Committee NOTED the documentation circulated. In November 2021, SOLAS requested a one-year extension of validation for the following programmes:

- 6.1.4.1 PG22050, Advanced Certificate in Craft - Metal Fabrication, Level 6, Major Award, 240 FET Credits
- PG22046, Advanced Certificate in Craft - Electrical, Level 6, Major Award, 240 FET Credits

In September 2015, the PAEC approved the validation of five Advanced Certificate Craft Awards: Carpentry and Joinery, Electrical, Heavy Vehicle Mechanics, Metal Fabrication and Plumbing, for five years until August 2020.

In June 2020, the PAEC agreed an 'extension of period of enrolment for validated programmes' by four months to 31 December 2020. This was granted in recognition of the current difficulties arising from the Coronavirus pandemic. In December 2020, the PAEC agreed a further extension of validation.

The Committee DEFERRED consideration of the request to extend the last intake date of the above programmes.

6.1.5 **Fast Track into Information Technology**

The Committee NOTED the documentation circulated.

In November 2021, Fast Track into Technology (FIT) requested a one-year extension of validation of the programmes below.

- 6.1.5.1 PG23422, Advanced Certificate in Computer Networking, Level 6, Major Award, 240 FET Credits (Apprenticeship)
- PG23423, Advanced Certificate in Software Development, Level 6, Major Award, 230 FET Credits (Apprenticeship)

FIT indicated that due to the current pandemic they had to divert significant QA resources to manage the continuity arrangements for online delivery of the Advanced Certificate in Computer Networking and the Advanced Certificate in Software Development. FIT expect this resource requirement to continue for several months. FIT was planning to complete programme review, research and stakeholder engagement during this time. FIT indicated that with current resources they would not be able to complete the necessary activities to review and update the two named programmes.

FIT has requested an extension for both programmes until December 2022, to allow for an active intake through the calendar year. FIT expects to complete the programme review in the latter months of 2022.

The Committee APPROVED the request to extend the last intake date of the programme to December 2022.

#### **6.1.6 Mayo, Sligo and Leitrim ETB**

The Committee NOTED the documentation circulated.

In October 2021, Mayo, Sligo and Leitrim ETB (MSLETB) requested a one-year extension of validation for the Programme below:

##### **6.1.6.1 PG23911, Certificate in Craft Butchery, Level 5, Major Award, 155 FET Credits (Apprenticeship)**

MSLETB has indicated that due to the current pandemic it has had to divert significant QA resources to manage the continuity arrangements for online delivery of the Certificate in Butchery. MSLETB has requested an extension for the programme until December 2022, to allow for an active intake through the calendar year. MSLETB expects to complete the programme review in the latter months of 2022.

The Committee APPROVED the request to extend the last intake date of the programme above to December 2022.

#### **6.1.7 Kerry ETB**

The Committee NOTED the documentation circulated.

On 22 November 2021, Kerry Education and Training Board (KETB) informed QQI that an expert panel member had to withdraw from the programme review and revalidation panel that was to be held on 23 November 2021. The independent panel for the programme review had to be stood down. The panel will be re-established in January 2022.

Kerry ETB has requested an extension for the programme below until April 2022 which would allow for an active intake until April 2022. Kerry ETB indicated that they would have the review completed and revalidation applications submitted to QQI in early 2022.

##### **6.1.7.1 PG23401, Advanced Certificate in Culinary Arts, Level 6, Major Award, 240 FET Credits (Apprenticeship)**

The Committee APPROVED the request to extend the last intake date of the programme above to April 2022.

#### **6.1.8 Hibernia College**

The Committee NOTED the documentation circulated.

In November 2021, Hibernia College requested an extension of validation for the two programmes below:

- 6.1.8.1 PG21195, Professional Master of Education in Post Primary Education (PME), Level 9, Major Award, 120 Credits
- PG21507, Professional Master of Education in Primary Education, Level 9, Major Award, 120 Credits

The Professional Master of Education in Primary Education and the Professional Master of Education in Post-Primary Education programmes are approved by the Teaching Council for the purposes of teaching in primary and post-primary schools respectively. The timelines for approval of these programmes with the Teaching Council were synchronised with QQI validation and programme review periods i.e., they are approved for five years. Both programmes were due for review with QQI and the Teaching Council during 2019. The Teaching Council has recently updated its schedule for review and accreditation of PME programmes, and Hibernia College is scheduled for this process in October 2022.

A one-year extension to the QQI validation period for these programmes would enable Hibernia College to synchronise its QQI review and revalidation processes in line with the Teaching Council's reaccreditation processes.

The Committee APPROVED the request to extend the last intake date of the programmes above to August 2023.

In April 2021, the PAEC validated, with one condition, the two Holmes Institute Dublin programmes below:

- PG24452 Bachelor of Arts (Honours) in Business
- PG24453 Certificate in Business

The executive considers that the outstanding condition of validation which had been in place on these programmes has been met and that no further follow-up is required.



## **7.2 Update on the follow-up of conditions of QA Approval**

### **7.2.1 Barrow Consultancy and Training**

As part of its internal quality assurance procedures, the executive is required to follow up on any Conditions of QA Approval imposed by the Programmes and Awards Executive Committee.

In February 2021, the PAEC approved the QA procedures of Barrow Consultancy and Training with two Conditions of QA Approval.

In March 2021, Barrow Consultancy and Training confirmed that it had addressed condition 2 and had a plan in place to address condition 1 as required.

The Committee NOTED that the executive now considers condition 1 to be met and that no further follow-up is required.
