The rationale for this request was as follows:

IICP Education and Training Limited wished to extend the duration of the above programmes by one year to align the revalidation of the programmes with the counselling and psychotherapy regulations due for imminent publication by the professional body, CORU. An extension request for one year was being sought for the above programmes to allow the team to conduct its review and submit a revalidation that is informed by the CORU standards.

The Committee APPROVED the request to extend the last intake date of the programmes for one year.

#### **6.1.2 Hibernia College**

The rationale for this request was as follows:

Hibernia College wished to extend the duration of the above programme, as to date, no learners have enrolled on the programme and therefore would be unable to conduct a meaningful programme review that is required as part of the revalidation process. The Nurturing Skills Learner Fund (NSLF) in 2023 has since created an opportunity to enable recruitment of learners to the Hibernia College programme. This initiative provides targeted financial support to learners, thus making the programme more accessible to a broader range of learners. With the assistance of the NSLF funding, Hibernia College intend enrolling learners to the programme for the first time in September 2025, which will assist in the programme review for the revalidation process.

The Committee APPROVED the request to extend the last intake date of the programme for one year to September 2025.
