2 FEES FOR PROGRAMME VALIDATION – HIGHER EDUCATION PROGRAMMES

2.1 FEES FOR AN APPLICATION FOR VALIDATION OF A PROGRAMME OF HIGHER EDUCATION⁷

Standard Validation

Fee	Applicability ⁸
€10,000	Fee for higher education programme with 60 ECTS or more
€5,000	Fee for higher education programme with less than 60 ECTS

Note:

In the case of a submission with embedded programmes the standard validation fee (see 2A above) will apply to the programme with the highest number of ECTS. The fee for each additional programme included in the submission suite will be calculated based on €100 per ECTS, subject to a maximum of €10,000 in respect of each additional programme which has 60 ECTS or more, and €5,000 in respect of each additional programme with less than 60 ECTS. (See Appendix 1 for examples.)

This does not apply to Special Purpose Awards (SPA). These are stand-alone awards and cannot be submitted as part of a suite. A fee of €5,000 applies to each SPA where ECTS are equal to or less than 60.

2.2 FEE FOR A HIGHER EDUCATION PROGRAMME WITH 10 ECTS OR LESS (MICRO-CREDENTIAL)

Fee	Applicability
€2,000 for a validation period of 2 years or less, plus €1,000 for each additional year of validation	Fee for a higher education programme with 10 ECTS or less (micro-credential)

2.3 FEE FOR VALIDATION OF A PROGRAMME OF HIGHER EDUCATION WHERE RESPONSIBILITY FOR ARRANGING AN INDEPENDENT EVALUATION REPORT IS DEVOLVED

The fee in respect of an application for validation of a programme of higher education where responsibility has been devolved is 50% of the standard validation fee.

2.4 FEE FOR VALIDATION OF A PROGRAMME OF HIGHER EDUCATION LEADING TO A JOINT AWARD

The fee in respect of an application for the validation of a higher education programme leading to a joint award will not be less than 50% of the standard validation fee (see 2A above). In some circumstances, it may equal or exceed the standard fee. This will depend on the circumstances and the complexity involved.

2.5 FEE FOR OVERSEAS VALIDATION OF HIGHER EDUCATION PROGRAMMES

All overseas validations will be charged the standard validation fee (see 2A above) plus travel and subsistence for panel members and members of the QQI executive, and other additional costs incurred.

2.6 FEE FOR THE REVALIDATION⁹ OF A HIGHER EDUCATION PROGRAMME (SECTION 80 (F))

Fee	Applicability
€1,500 minimum	A charge of €1,500 will apply to the first programme, with an additional fee of €10 per credit for each additional embedded programme, subject to a maximum of €1,500 per programme.

Note 1: This fee is for revalidation conducted following a programme review process managed by the provider in line with terms of reference agreed by QQI.

Note 2: QQI may decide that a new validation is required on the expiry of the validation of a programme, in these cases the standard fee under Section 2A above applies.

Note 3: If the revalidation is conducted by QQI (e.g. where terms of reference for the provider's programme review were not agreed by QQI), the standard validation fee will apply (see Section 2A above).

Note 4: If a new award (major, minor, or exit) is submitted with an application for revalidation of the parent programme, the standard fee at Section 2A will apply to the validation of each new awards.

2.7 FEE FOR THE VALIDATION OF AN EMBEDDED PROGRAMME LEADING TO AN EXIT AWARD

A fee will not apply to the validation of an embedded programme leading to an exit award. The exit award fee concession is only available for major awards. An exit award is available in exceptional and limited circumstances when a learner cannot complete the programme they enrolled on. An exit award programme should not be advertised.

Note: the standard validation fee applies to applications for the validation of any other type of embedded programme.

2.8 FEES FOR THE SUBMISSION OF A PROPOSAL TO CHANGE A CONDITION OF PROGRAMME APPROVAL FOR EXAMPLE EXTENSION OF VALIDATION PERIOD, INCREASE IN ENROLMENT NUMBERS, ETC

Fee	Applicability
One fifth of the standard validation fee (see 2A above) or a minimum of €3,000	The fee applies to a single programme with 60 ECTS or more. <i>If the change requested is not approved the fee will not be refunded.</i>
One fifth of the standard validation fee (see 2A above) or a minimum of €1,000	The fee applies to a single programme with less than 60 ECTS. <i>If the change requested is not approved the fee will not be refunded.</i>

2.9 WITHDRAWAL OF AN APPLICATION FOR VALIDATION

Applications for the validation of programmes may be withdrawn prior to the start of the independent evaluation stage. A partial refund of fees (up to 50% of the fees received in respect of the application) may be considered at this point. Once the independent evaluation stage has started, QQI will normally progress to a determination and publish the independent evaluation report.
