A bespoke process was put in place and a panel appointed comprising a Chair, a report writer, and a blended leaning expert. SNMCI has accepted the findings of the report and has agreed to implement the advised improvements set out by the panel.

13. THEMATIC ANALYSIS OF PROVIDER REENGAGEMENT (QA APPROVAL)

13.1 Thematic Analysis of Provider Reengagement (QA Approval)

The Committee NOTED the documentation circulated.

Earlier this year, QQI commissioned Dr Orlaith McCaul to undertake a thematic analysis of the reengagement process to date (September 2018 to February 2020). Dr McCaul's report is now complete and has been published on the QQI website: https://www.gqi.ie/Downloads/QQI%20Reengagement%20Report-Web.pdf

The executive is considering the findings and recommendations of the report to further enhance the process and have already implemented a number of changes to address issues raised by both providers and panel members (e.g. the creation of standing panels to help ensure consistency; increased response times for providers). The executive will prepare a formal response to the report, which will address each recommendation, and which will also be published.

QQI is reassured that the majority of providers found reengagement to be a positive and worthwhile experience. 100% of providers stated that the process had improved their QA systems. A typical provider quote cited in the report reads:

It was a very worthwhile process, professionally undertaken and the engagement with the panel was collegial, mutually respectful and positive. Likewise, the QQI staff involved were exceptionally courteous, professional and supportive. (Provider, 2020)

QQI continues to operate the reengagement process apace, with approximately 20 providers scheduled to apply for reengagement per quarter between now and November 2022 (the legal deadline by which all applications for reengagement must be submitted). All private and independent HE providers have now submitted applications for reengagement, with a small number still in process.

14. SOLAS - QA APPROVAL UPDATE

14.1 SOLAS - QA Approval Update

The Committee NOTED the documentation circulated.

The Committee noted that SOLAS has submitted two applications for QA approval. Meetings have been held with SOLAS executive team but to date, the QA has not been approved.

The pandemic has further delayed SOLAS application. It was agreed that SOLAS will submit, within the next few weeks, their *current* quality assurance procedures for Craft Apprenticeships, E-College and CSCS programmes, together with an implementation plan, for evaluation by QQI executive. It will culminate in a QQI senior management level dialogue meeting to conclude the approval process and agree the way forward.

When the longer-term picture for Craft Apprenticeships is clearer, the approval of the quality assurance for these programmes will be revisited.
